**AN ORDINANCE AMENDING SECTION 1 AND 2 OF ORDINANCE NO. 2015-272 RELATIVE TO
DAILY WAGE/SALARY OF JOB-HIRED EMPLOYEES**

Section 3. Other related ordinances inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 4. This Ordinance shall take effect upon approval.
