II, Sec. 2 (3) of RA 9165 docketed under Criminal Case No. 16-6977 dated June 6, 2016, issued and signed by the Assisting Judge of Regional Trial Court 6<sup>th</sup> Judicial Region Branch 68, Dumangas, Iloilo and was appraised of his constitutional rights under Miranda doctrine, brought and detained this police station for proper disposition pending turned-over to the court concerned;

**WHEREAS**, the Local Government Unit of Mina grants the amount of Ten Thousand Pesos (P10,000.00) as a reward for every accomplishment in violation of R.A 9165 “known as Dangerous Drug Act of 2002”;
