WHEREAS, person was arrested by virtue of crime he committed for violation of Sec. 5 and 11, Art. II, of RA 9165 docketed under I.S. No. VI-II-INQ-16j-01167 to 01 167 – A, subscribed and sworn to by the Assistant Provincial Prosecutor and was appraised of his constitutional rights under Miranda doctrine, brought and detained this police station facilities prior subjected to drug test examination;
