**RESOLUTION NO. 2016 - 115**

**RESOLUTION ENDORSING THE PROPOSED CONSTRUCTION OF A CONVENTIONAL POULTRY HOUSE HAVING A CAPACITY OF 10,000 HEADS AT BARANGAY ABAT, MINA, ILOILO**

WHEREAS, Ms. Mary Salve L. Pe, in partnership with Bounty Agro Venture, submitted their intention to put up a poultry project with a population of 10,000 heads stocking population or less to be established at Brgy. Abat, this Municipality;

WHEREAS, attached to their application are the necessary requirements, such as, 1) Barangay Resolution No. 2016-027 of Barangay Abat, Mina, Iloilo, Iloilo approving the proposed project, 2) minutes of the three (3) consecutive public hearings/general assemblies last May 15, June 15 and June 24, 2016, 3) List of attendees and their signatures to the three (3) public hearings conducted; and 4) Certificate of Non-coverage issued in the name of MS. MARY SALVE L. PE on October 20, 2016 for the PE-CHIN POULTRY FARM;

WHEREAS, the proponent is willful to comply with its commitment to maintain cleanliness and sanitation and the requirements imposed by the Environmental Management Bureau of the Department of Environment and Natural Resources, Municipal Ordinances and other requirement to avoid closure thereof;

WHEREAS, the proposed poultry farm project is likewise considered beneficial to the economic growth and development of Barangay Abat in particular and of the entire Municipality as well, hence approval of the same is hereby recommended;

WHEREAS, this resolution does not exempt the proponent from other requirements such as business permit, etc., imposed by the Municipality.
