RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO , TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DOH-RO VI , REPRESENTED BY DR. MARLYN W. CONVOCAR, REGIONAL DIRECTOR IV, WESTERN VISAYAS FOR THE IMPLEMENTATION OF INTEGRATED CLINIC INFORMATION SYSTEM (iClinicSys)

WHEREAS, presented for consideration is the letter from the office of the Mayor requesting authority from this Sanggunian to enter and sign into a MOA with the DOH-RO VI for the implementation of Integrated Clinic Information System (iClinicSys) in the Municipality of Mina;

WHEREAS, the DOH, being a national agency, ensures the protection of health of every Filipinos, by providing assistance to health partners and stakeholders on the information and Communication Technology (ICT) in health care to improve service delivery and access to health information;

WHEREAS, RA 7160, otherwise known as the Local Government Code of 1991 mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all LGUs at all levels;

WHEREAS, other pertinent informations related to the implementation of the iClinicSys which both the LGU and the DOH-RO VI commit to comply are stipulated in the draft MOA presented to this Sanggunian;

WHEREAS, authority to sign by the Municipal Mayor from this Sanggunian pursuant to Section 444 (b)(i)(vi).

NOW, THEREFORE:
