RESOLUTION CONFIRMING THE ANNUAL BUDGET OF BRGYS. JANIPA-AN WEST,
AND TUMAY, MINA, ILOILO FOR CY 2017 FOR REVIEW AND EVALUATION

Whereas, presented to this Body for review and evaluation is the annual budget of Barangays Janipa-an West, and Tumay, Mina, Iloilo with corresponding amount itemized as follows:

A. **Barangay Janipa-an West** in the amount **P1,510,938.00**

1. The amount Estimated Appropriation for CY 2017 broken down as follows:

a. Personal Services	-----	P747,200.00
b. Maintenance and Operating Expenses	-----	162,963.00
c. Capital Outlay	-----	-0-
d. Non-Office Expenditures	-----	<u>P600,775.00</u>
Total Estimated Expenditures	-----	<u>P1,510,938.00</u>

B. **Barangay Tumay** in the amount **P1,590,409.00**

1. The amount Estimated Appropriation for CY 2017 broken down as follows:

a. Personal Services	-----	P787,200.00
b. Maintenance and Operating Expenses	-----	249,166.00
c. Capital Outlay	-----	-0-
d. Non-Office Expenditures	-----	<u>P554,043.00</u>
Total Estimated Expenditures	-----	<u>P1,590,409.00</u>

Whereas, upon review of the entirety of the annual budgets of the concerned aforesaid barangays, the Honorable Body finds the same to be in accordance with the provisions of RA 7160 particularly Section 325 thereof which pertains to PS (Personal Services) limitation;

Whereas, it is also recommended that provisions under *DILG-DBM JMC No. 2011-1* shall be observed in allocating the 20% development fund of the barangay;

Whereas, the Sanggunian considered the entirety of the budgets of the above-mentioned barangays operative upon effectivity as they are all responsive to the welfare and needs of their constituency, hence this confirmation.
