WHEREAS, the LGU of Mina is the owner of a parcel of land known as lot No. 1709 located at Brgy. Mina East, Mina, Iloilo with an aggregate area of one thousand seven hundred nine (1,709) square meters;

WHEREAS, the LGU of Mina, represented by the Municipal Mayor is willing to donate portion of the parcel of land equivalent to two hundred fifty (250) square meters more or less to the DLIG Regional Office VI, Iloilo City represented by Atty. Anthony C. Nuyda, Regional Director; for the constructions of Local Government Operations Center (LGOC);

WHEREAS, this Sanggunian, through the honorable Vice Mayor Bernardino P. Chichirita, has received a letter from the Office of the mayor requesting authority to enter and sign into a deed of donation consistent with the provision of Section 444 (b)(1)(vi) of RA 7160
