RESOLUTION NO. 2017 - 037

RESOLUTION GRANTING THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) MONTHLY HONORARIUM TO BOTH MRS. VIRGINIA P. BORRA, HEAD OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA), AND MR. ERNESTO P. PARREÑO, FEDERATION OF THE SENIOR CITIZENS AFFAIR PRESIDENT (FSCAP)

WHEREAS, as mandated under R.A. 9994 (Expanded Senior Citizens Act of 2010, under section 6 to provides that, there shall be established office for the Senior Citizens Affairs (OSCA) in all cities and municipalities to be headed by the senior citizens, who shall be appointed by the Mayor for a term of three (3) years, without re-appointment but without prejudice to an extension if so exigency so requires;

WHEREAS, said appointee shall be chosen from a list of three (3) nominees as recommended by a general of the senior citizens organization in the Municipality;

WHEREAS, the OSCA head shall be appointee to serve the interest of the senior citizens and shall not be removed or replaced except for reasons of death, permanent disability or ineffective performance of his duties to the detriment of fellow citizens;

WHEREAS, the OSCA head shall entitled to receive an honorarium of an amount of at least equivalent to Salary Grade 10 to be approved by the LGU concerned. Hence, there is an insufficiency of budget, thereby the committee recommends that an amount of One Thousand Pesos (P1,000.00) shall be given to the OSCA head which amount shall be subject to adjustment as to the sufficiency of budget;

WHEREAS, an amount of One Thousand Pesos (P1,000.00) monthly honorarium shall likewise be given to Mr. Ernesto P. Parreño, President, Federation of Senior Citizens Affairs President (FSCAP) for his services in assistance the formulation of plans, activities and programs for the interest of the senior citizens in the Municipality of Mina, Iloilo;

WHEREAS, the said amount shall be chargeable to the Gender and Development (GAD) fund aid to elderly and disabled person's and shall take effect on January 2017.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION GRANTING THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) MONTHLY HONORARIUM TO BOTH MRS. VIRGINIA P.
