RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A DEED OF DONATION AND ACCEPTANCE WITH THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY THE HON. GOVERNOR ARTHUR D. DEFENSOR, SR., PROVINCIAL CAPITOL, BONIFACIO DRIVE, ILOILO CITY

WHEREAS, the Provincial Government of Iloilo is the owner of one (1) unit Pump Engine Set with accessories and five (5) units grass cutter with standard tools and accessories which will be used by its constituents to help them elevate their method of farming; and recognizes the efforts of the farmers in the Province of Iloilo to increase their farm production and develop new methods of farming through farm machinery, equipment and tools;

WHEREAS, the Municipality of Mina is in need of Pump Engine Set with accessories and Grass Cutter with standard tools and accessories for the use of its constituents;

WHEREAS, the Iloilo Provincial Government, as an act of liberality and generosity, hereby voluntarily and freely gives unto the municipal government of Mina the above-mentioned agricultural and forestry equipment particularly farmers beneficiary in Brgy. Agmanaphao and Mina East, all of Mina, Iloilo;

WHEREAS, both parties hereof shall adhere to the conditions stipulated in the Deed of Donation and Acceptance;

WHEREAS, an authority to sign by the Municipal Mayor from the Sanggunian to this effect is necessary pursuant to Section 444 (b)(1)(vi) of RA 7160, otherwise known as the Local Government Code of 1991, hence this resolution.
