## **RESOLUTION NO. 2017 - 049**

RESOLUTION AFFIRMING AND FAVORABLY ENDORSING THE CONSTRUCTION OF FOUR (4) UNITS FLOOD CONTROL PROJECT ALONG THE SUAGUE RIVER BOTH UPSTREAM AND DOWNSTREAM OF THE EXISTING SUAGUE BRIDGE UNDER THE FY 2017 LOCAL DEVELOPMENT SUPPORT FUND-FINANCIAL ASSISTANCE (LGSF-FA) TO LOCAL GOVERNMENT UNITS AMOUNTING TO ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00)

WHEREAS, the LGU of Mina is centrally traversed by a Suague River where there is an existing Suague Bridge providing access from the town proper to other ten (10) barangays at the northern part of this locality;

WHEREAS, aside from the bridge, lot of infrastructure projects situated under the Suague River are critically at stake which need protection against erosions anytime floods occur;

WHEREAS, the LGU of Mina needs to avail of the LGSF-FA for the flood control project to protect its existing infrastructures situated within the critically endangered areas, such as, the national highway, slaughterhouse, public market, cemetery, etc., including the Suague river bridge;

WHEREAS, per program of works prepared by the DPWH, Iloilo 2<sup>nd</sup> Engineering District, an amount of One Hundred Fifty Million Pesos (P150,000,000.00) is needed for this purpose;

WHEREAS, this project above-mentioned has been included in the Municipality's Development Plan, hence this endorsement.
