RESOLUTION EXTENDING COMMENDATION TO MINA PNP LED BY PSINSP MA. THERESA G. LERO, OFFICER IN-CHARGE TOGETHER WITH PO3 JOHN BRILLO, PO1 FERDINAND ARMADA, PO2 FRED RICHARD DAQUITA, PO2 FRANKLIN JOHN LUZARITA AND PO2 ANDY DATILES, FOR A SUCCESSFUL OPERATION AGAINST VIOLATION OF R.A. 9165 KNOWN AS "COMPREHENSIVE DANGEROUS DRUG ACT OF 2002", R. A 10591 "ILLEGAL POSSESSION OF EXPLOSIVES AND AMMUNITION" AND R. A. 9287 "ILLEGAL GAMBLING" AND GRANTING THE REWARD OF TEN THOUSAND PESOS (P10,000.00)

WHEREAS, that at about 3:55 o'clock in the afternoon of May 8, 2017 at Brgy. Janipa-an West, Mina, Iloilo, PNP personnel of Mina Municipal Police Station led by **PSINSP Ma. Theresa G. Lero**, Officer In-Charge together with **PO3 JOHN BRILLO, PO1 FERDINAND ARMADA, PO2 FRED RICHARD DAQUITA, PO2 FRANKLIN JOHN LUZARITA AND PO2 ANDY DATILES**, conducted a buy bust operation against **Dante Gazo y Mircurio, 39, years old, married**, outside the house of Elma Caragayan at Brgy. Janipa-an West, Mina, Iloilo, for possession of illegal drugs wherein the subject person, together with Jonelyn Caragayan y Belandres, 30 years old and Gemma Losbañes y Solen, 46 years old, married, all are residents of the same place for illegal gambling, to confirm the alleged involvement of the subject on the illegal drug operation which was duly coordinated with PDEA R6 with COC Nr. 20003-052017-0039;

WHEREAS, persons were placed under arrest and informed of the nature of the offenses they committed and cause of their arrest for violation of Sec. II, Article II of R.A. 9165 (*Dante Gazo y Mircurio*), R.A. 10591 "Illegal Possession of Explosives and Ammunition", and R. A. 9287 "Illegal Gambling", subscribed and sworn by the Provincial Prosecutor and was appraised of his constitutional rights under Miranda doctrine, brought and detained this police station pending for filing appropriate cases concerned;

WHEREAS, the Local Government Unit of Mina is granting the amount of Ten Thousand Pesos (P10,000.00) as a reward for every accomplishment in violation of R.A 9165 "known as Dangerous Drug Act of 2002";

WHEREAS, with this meritorious and exemplary job well done, the Municipal Officials and employees and the resident of Mina, Iloilo highly appreciated such performance and worthy of commendation, hence this Resolution.
