RESOLUTION No. 2017 - 112

RESOLUTION EXTENDING COMMENDATION TO MINA PNP FOR SUCCESSFUL IMPLEMENTATION OF SEARCH WARRANT NO. 17-081 ISSUED BY HON. VICENTE V. GO, EXECUTIVE JUDGE BRANCH 68, DUMANGAS, ILOILO FOR VIOLATION OF RA 10591

WHEREAS, at about 4:30 o'clock in the morning of July 18, 2017, joint elements of Mina PNP team led by PSINSP Ma. Theresa G. Lero, Officer-In-Charge, and her men, together with SOG team 2 led by PSINSP Bonifacio Alabe Jr., and his members, whose names are mentioned in the Spot Report hereto attached proceeded to Barangay Tipolo, Mina, Iloilo at the house of Francis Corsino Y Huesca to conduct operation on implementation of search warrant by virtue of Search Warrant No. 17-081 issued and signed by Hon. Vicente V. Go, Executive Judge of Branch 68, Dumangas, Iloilo for violation of RA 10591;

WHEREAS, as they approach the house of the subject, Francis Corsino Y Huesca, certain Arnel Planco Y Adorio came out from the adjacent house carrying a homemade 12 gauge shotgun and he was immediately arrested by the operating PNP members. Recovered from his possession and control are: One (1) homemade 12 gauge shotgun, two (2) live ammunitions and one (1) magazine. Said items were recovered by P02 Ricky Leal;

WHEREAS, confiscated inside the house of the subject, Francis Corsino Y Huesca were: one (1) pc. Short break type pistol (12 gauge shotgun) and four (4) pieces gauge live ammunitions. Such items were recovered by P03 John Brillo assigned as searcher;

WHEREAS, all confiscated items were properly marked and photographed at the scene with the presence of elected Barangay officials PB Jornil Z. Adorio, Brgy. Kgw. Romulo Fortoza and chief Brgy. Tanod Wilfredo Adorio, which will serve as evidence against the subject Francis Corsino Y Huesca and Arnel Planco Y Adorio;

WHEREAS, in view of the excellent performances executed by the above-mentioned personnel, the Sangguniang Bayan of Mina, Iloilo hereby extend this commendation to the PNP – Mina as a whole for the job well done.

NOW, THEREFORE:
