**WHEREAS,** the Municipality of Mina is a recipient of KALAHI CIDSS-NCDDP Tier 2 Grant provided to municipalities in 177 areas within Panay and Guimaras island;

WHEREAS, Resolution No. 006, series of 2017, of the Municipal Inter-Agency Committee integrates the seven (7) approved subproject listing qualified to avail of the KC-NCDDP Tier 2 Grant as prioritized during the Municipal Inter-Barangay Forum attended by the Municipal Coordinating Team (MCT) and Municipal Inter-Agency Committee (MIAC), including the Barangay Representative Team (BRT) and Project Preparation Team (PPT);

Capul-an for Solar Powered-Led Streetlights Construction; d.) Janipa-an West for Solar Powered-Led Installation: e.) Singay for Barangay Road Concreting; f.) Tolarucan for Solar Powered-Led Installation; and g.) Yugot for Construction of one (1) unit 2CI E/S Building with Amenities;

WHEREAS, the Liga ng mga Barangays has concurred the approval of the Subproject proposals and favorably endorsing the same through its Liga Resolution No. 2017 - 15, to this Sanggunian for adoption;

**WHEREAS,** the subprojects identified by the concerned seven (7) barangays truly addressed the needs and welfare of their constituents, hence this adoption.
