**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE WEST VISAYAS STATE UNIVERSITY-JANIUAY CAMPUS, JANIUAY ILOILO REPRESENTED BY DR. RAYMUND B. GEMORA, CAMPUS ADMINISTRATOR FOR LABORATORY, PHYSICAL/MEDICAL EXAMINATION, AND CONSULTATION SERVICES TO THEIR STUDENTS RESIDING WITHIN THE TERRITORIAL JURISDICTION OF MINA**

**WHEREAS**, the West Visayas State University (WVSU)-Janiuay campus authorizes the WVSU-Janiuay Campus Medical Unit, through Mrs. Nanette Teresita S. Tirador, to refer their students coming this Municipality to the Mina Laboratory and Medical Clinic for laboratory, physical/medical examination as school's policy in admitting new incoming students in that institution;

**WHEREAS**, the MOU to this concern shall be executed between the two (2) parties: the West Visayas State University – Janiuay Campus represented by its Campus represented by its Campus Administrator and the Mina Municipal Health Unit, represented by the Municipal Mayor, Hon. Rey P. Grabato;

**WHEREAS**, an authority to sign by the Municipal Mayor to this effect shall be granted by this Sanggunian pursuant to Section 444 (b)(i)(vi) of R.A. 7160.
