**RESOLUTION No. 2017 – 135**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO AND THE MUNICIPAL TREASURER, ROMEO F. TABARNILLA TO OPEN AN ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES (LBP) – JANIUAY BRANCH, JANIUAY, ILOILO AND FURTHER DESIGNATING THEM AS THE AUTHORIZED SIGNATORIES FOR ANY OFFICIAL TRANSACTIONS RELATIVE THERETO**

**WHEREAS**, per Memorandum of Agreement (MOA) executed by and between the Municipal Government of Mina represented by the Municipal Mayor, Hon. Rey P. Grabato and the seven (7) KC-NCDDP TIER 2 recipient barangays concerned represented by their respective punong barangays, namely: 1.) Agmanaphao, 2) Bangac, 3.) Capul-an, 4.) Janipa-an West, 5.) Singay, 6.) Tolarucan and 7.) Yugot, Barangays above-mentioned shall transfer the amount of One Hundred Thousand Pesos (P100,000.00) each to the Mina Municipal Treasury as Barangay counterpart to augment the salaries of KALAHI CIDSS – NCDDP workers assigned by the DSWD Regional Office VI and other miscellaneous expenses for the implementation of KC – NCDDP Tier 2 subprojects in the said seven (7) barangays of the Municipality;

**WHEREAS**, it is also stipulated in MOA the role of the parties concerned in as far as management and disbursement of the said fund;

**WHEREAS**, the money transferred to the Municipal Treasury shall be deposited to the bank, specifically the LBP-Janiuay Branch prior to its disbursement for a specific purpose.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO AND THE MUNICIPAL TREASURER, ROMEO F. TABARNILLA TO OPEN AN ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES (LBP) – JANIUAY BRANCH, JANIUAY, ILOILO AND FURTHER DESIGNATING THEM AS THE AUTHORIZED SIGNATORIES FOR ANY OFFICIAL TRANSACTIONS RELATIVE THERETO.
