**RESOLUTION NO. 2017 - 141**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DSWD, BATASANG PAMBANSA COMPLEX, CONSTITUTION HILLS, QUEZON CITY REPRESENTED BY HON. ARTHUR D. DEFENSOR SR., GOVERNOR, PROVINCE OF ILOILO FOR THE IMPLEMENTATION OF NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS – PR) IN THE MUNICIPALITY OF MINA**

**WHEREAS**, the DSWD is mandated to provide assistance to other National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organization (NGOs), People’s Organization (POs), and members of the civil society in the implementation of programs, projects and services that will alleviate poverty and empower disadvantaged individuals, families and communities improve their quality of life;

**WHEREAS**, under Executive Order (EO) No. 867 signed on March 09, 2010, the DSWD has further been mandated as the lead agency implementing the National Household Targeting System for Poverty Reduction (NHTS-PR), also known as Listahan, to establish a system for identifying who and where the poor households are, maintain a system that will serve as repository of the data on poor households, updates the data every four (4) years, and share, the data, especially to NGAs, which shall serve as the basis in the selection of social protection programs nationwide;

**WHEREAS**, to ensure effective, compliance of the program implementation, a Memorandum of Agreement (MOA) shall be executed by and between the DSWD to be represented by Hon. Arthur D. Defensor Sr., in his capacity as provincial governor, and the Municipal Government of Mina represented by the Municipal Mayor, Hon. Rey P. Grabato;

**WHEREAS**, an authority to sign by the Municipal Mayor to this effect is necessary pursuant to Section 444 (b)(i)(vi) of R.A. 7160.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
