**RESOLUTION NO. 2017 - 145**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN IN A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH (DOH) REPRESENTED BY DIRECTOR MARLYN W. CONVOCAR, DOH-REGIONAL OFFICE VI, ILOILO CITY FOR THE DONATED MEDICAL EQUIPMENT**

**WHEREAS**, the DOH launched the “Kalusugan Pangkalahatan” which envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of basic medical equipments;

**WHEREAS**, in 2004, PhilHealth re-branded the Primary Care Benefit Package as Tamang Serbisyo sa Kalusugan ng Pamilya or “TseKap” for easy recall and to increase demand for primary care services;

**WHEREAS**, the Department of Health introduced the TSeKap Equipment Package as a means to provide LGU health facilities, specifically the RHUs and BHSs, with basic medical equipment to improve delivery of primary health care service;

**WHEREAS**, each TSeKap Equipment Package procured by DOH amounting to Thirty Four Thousand Nine Hundred Ninety Six Pesos and 50/100 (P34,996.51) consists of: a.) two (2) non-contact thermometer; b.) One (1) stethoscope; c.) One (1) digital BD apparatus; d.) one (1) glucometer; e.) One (1) dressing set; f.) Two (2) nebulizers; and g.) One (1) storage box;

**WHEREAS**, the aforesaid equipments shall be donated to this LGU subject to the conditions set in the draft Deed of Donation;

**WHEREAS**, an authority to sign by the Municipal Mayor from this Sanggunian to this effect is required pursuant to Section 444 (b)(i)(vi) of R.A. 7160.

**NOW, THEREFORE:**
