TABARNILLA, TO OPEN A SPECIAL TRUST FUND ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES (LBP)-JANIUAY BRANCH, JANIUAY, ILOILO FOR THE MULTIPURPOSE TEEN CENTER ESTABLISHED IN MINA NATIONAL HIGH SCHOOL, BANGAC-TALIBONG GRANDE, MINA, ILOILO**

**WHEREAS**, school based multipurpose teen center was established at the Mina National High School purposely to implement the Adolescent Health and Youth Development Program (AHYDP) under the Philippine Population Program spearheaded by the Provincial Population Office;

**WHEREAS**, the objective of this program is contribute to the improvement and promotion of the total well-being of young people, such as, reduction of the incidence of teenage pregnancy, early marriage, and other psychosocial concerns;

**WHEREAS**, the multipurpose teen center will serve as the venue for recreational programs, projects and activities, personality development, skills enhancement, promote friendship and other development activities for the welfare and development of youths and development;

**WHEREAS**, the various funding support from the local governments (provincial, municipal and barangays) and cash donations from private sectors (NGOs/CSOs/private individuals) may be received for the continuous operations and maintenance of the center, hence this authority.
