APPROPRIATION ORDINANCE NO. 2017 - 001

AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 01 SERIES OF 2017 FOR THE GENERAL FUND OF THE MUNICIPALITY OF MINA, PROVINCE OF ILOILO IN THE TOTAL AMOUNT OF THREE MILLION TWO HUNDRED EIGHT THOUSAND THIRTY TWO PESOS (P3,208,032.00)

WHEREAS, as per LBP Forms No. 9 hereto attached, the OIC-Municipal Treasurer and the ICO-Municipal Accountant has certified the availability of savings from vacant position of a Registrar II amounting to Two Hundred Eight Thousand Thirty Two Pesos (P208,032.00) and a surplus of Three Million Pesos (P3,000,000.00) from the New Revenue Sources or a total of P3,208,032.00 available for appropriations;

NOW, THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

Section 1. The amount of Two Hundred Eight Thousand and Thirty Two Pesos (P208,032.00) under the Local Budget Preparation Form No. 9 in Municipal Economic Enterprise Office (Operation of Mina Skills Training Center) is hereby appropriated to fund Supplemental Budget No. 01 series of 2017 for personal services on the operation of the Mina Skills Training Center (MSTC).

Section 2. The amount of Three Million Pesos (P3,000,000.00) under the Local Budget Preparation Form No. 9 for General Fund is hereby appropriated to the following:
