**RESOLUTION No. 2017 – 154**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO AND MUNICIPAL TREASURER, MR. ROMEO F. TABARNILLA, TO CLOSE THE MINA MUNICIPAL SPECIAL TRUST ACCOUNT NO. 0032-1466-86 WITH THE LAND BANK OF THE PHILIPPINES-ILOILO BRANCH, SOLIS-IZNART STS., ILOILO CITY**

**WHEREAS**, the Municipality of Mina, through the Honorable Mayor Rey P. Grabato P. Grabato and Municipal Treasurer, Mr. Romeo F. Tabarnilla was able to open a Special Trust Fund Account No. 0032-1466 with the LBP-Iloilo branch, Solis-Iznart Sts., Iloilo City for the loaned amount from the World Bank through the Disaster Management Assistance Fund (**DMAF**), purposely for the rehabilitation of the Mina Skills Training Center which was greatly damaged by typhoon Frank last June of 2008;

**WHEREAS**, the rehabilitation project has long been completed, and the loan herein stated has been fully paid by this LGU;

**WHEREAS**, the Municipality has still a remaining unexpended balance with the bank as of March 31, 2017 – April 2017, per Bank Statement issued by the LBP itself, which amount is considered as the Municipality's savings from the project implemented;

**WHEREAS**, the said balance remains and shall remain stagnant, as there had been no banking transactions made nor to be made in as far the project implementation is concerned.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO AND MUNICIPAL TREASURER, MR. ROMEO F.
