RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A CONTRACT OF WORK WITH NOE'S BUILDER'S, OWNER/PROPRIETOR WITH BUSINESS ADDRESS AT BANTUD ST., INGORE, LAPAZ, ILOILO CITY FOR THE CONSTRUCTION OF NATIONAL HEROES SHRINE WITH FLAGPOLES AND CARPORT WITH ROOFING IN FRONT OF MINA MUNICIPAL HALL

WHEREAS, presented for consideration is the letter received from the Office of the Mayor requesting for an authority from this Sanggunian to sign in the contract of work with Noe's Builders, Bantud St., Ingore, Lapaz, Iloilo City, for the construction of National Heroes Shrine with Flagpole and Carport with Roofing;

WHEREAS, the LGU of Mina was able to provide certain amount of One Million Pesos (P1,000,000.00) realized from its savings account for repayment of Municipal loans to finance the construction of the above-mentioned project;

WHEREAS, the said project was submitted to a public bidding for a One (1) Job Contract (furnishing of labor and materials) and Noe's Builders got the lowest calculated responsive bid to whom the Contract was awarded to;

WHEREAS, an authority to sign in the contract by the Municipal Mayor is a necessity pursuant Section 444 (b)(i)(vi).
