**ORDINANCE No. 2018 - 342**

**AN ORDINANCE DEPUTIZING ALL PUNONG BARANGAYS AND OTHER BARANGAY OFFICIALS TO INSPECT, MONITOR AND SUBMIT REPORTS REGARDING THOSE BUILDING CONSTRUCTIONS ERECTED WHETHER RESIDENTIAL, COMMERCIAL, INDUSTRIAL OR INSTITUTIONAL WITHIN THE RESPECTIVE JURISDICTION WITHOUT THE BUILDING PERMITS AS REQUIRED BY LAW**

**WHEREAS**, the New Building Code, PD 1096 as well as the Ordinance No. 2017-301, provide necessary requirements for building construction;

**WHEREAS**, various reports had reached the attention of this Sanggunian that many buildings whether residential, commercial, industrial or institutional were erected, both in urban and rural barangays, without acquiring the necessary permits to construct from the office of the municipality's designated building official;

**WHEREAS**, Barangay officials of the concerned barangays, are the one who have the best knowledge of their respective inhabitants and have all the knowledge about the construction status of the buildings being erected thereat.

**NOW, THEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

**Section 1.** Barangay Officials of the 22 barangays in the Municipality of Mina shall hereby be deputized to inspect, monitor and submit reports as to the status of the building already erected and occupied, as well those to be erected in their respective jurisdiction, whether or not they complied Rule III, Paragraph 2 (a) and (b) of Rules and Regulations Implementing PD 1096, otherwise known as the New National Building Code;

**Section 2.** Barangay Officials concerned through the Barangay Secretary shall hereby required to prepare reports of the data collected and submit the same to the designated Municipality's building officials for information and appropriate action;

**Section 3.** The Barangay concerned shall be allowed to a ten percent (10%) incentives from the collection of fees realized from the reports submitted, which shall accrue to the Barangay collection of revenues;

**Section 4.** This Ordinance shall take effect upon approval.

**ADOPTED** this 28<sup>th</sup> day of March 2018, on motion of **Hon. Jose G. Salanio Jr.**, duly seconded **Hon. Roger P. Cordero**.
