ORDINANCE No. 2018 - 345

AN ORDINANCE AMENDING SECTION 27, ARTICLE A, CHAPTER VII OF TAX ORDINANCE NO.
99-01, OTHERWISE KNOWN AS "THE MARKET CODE OF THE MUNICIPALITY OF MINA OF 1999"
TO BE CONSISTENT WITH ARTICLE B, P. 64 OF REVISED MUNICIPAL REVENUE CODE, AND
FURTHER INTEGRATGING OTHER PROVISIONS WHICH ARE DEEMED NECESSARY IN BOTH
MARKET AND REVISED REVENUE CODES

WHEREAS, Municipal Ordinance No. 99-01, known as "The Market Code of the Municipality of Mina of 1991" was promulgated and enacted last October 6, 1991". Since its promulgation, there had been no amendments made in so far as the provision of the revenues is concerned;

WHEREAS, section 27, Article A. Chapter VII of the Market Code remained as it was despite amendments in the Revised Municipal revised Code with similar provisions as reflected in Article B, Section 4B.01, page 64 of the latter.

NOW, THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

Section 1. Section 27, Article A, Chapter VII of the Market Code of 1991 of the Municipality of Mina shall hereby be awarded to be consistently the same with Article B Section 4.B01 of the Revised Municipal Revenue Code as follows:
