#### **ORDINANCE No. 2018 - 346**

# AN ORDINANCE STREAMLINING THE ORGANIC PLANTILLA OF PERSONNEL OF THE MUNICIPALITY OF MINA BY CREATING INDISPENSABLE POSITIONS AND DELETING THE UNNECESSARY ONES'

**WHEREAS,** the Office of the Mayor, through the Municipal Human Resource Management Office, request the creation and deletion of certain positions in the plantilla of personnel to effect efficient service to the general public;

**WHEREAS,** the Executive Department representative justified the necessity of this proposal, hence this enactment.

### NOW, THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:
