ORDINANCE No. 2018 - 347

AN ORDINANCE ADOPTING THE FLYERS AND A GUIDE ON THE PROPER MANAGEMENT OF SOLID WASTES PURSUANT TO RA 9003

WHEREAS, the Municipality of Mina was able to come-up with a flyers simplifying the objectives of RA 9003, otherwise known as the Solid Waste Management Act of 2000, which will serve as a guide for every individual or group of individuals in the proper management, and disposal of garbage generated within their respective places where they used to live and stay;

WHEREAS, the flyers entitled "Pamukaw-Hunahuna-Ang Hinun-anun nahanungod sa Basura sang tagsa ka Panimalay" will guide stakeholders and other members of the society in a simplest and very practical way of managing their garbage at home so as to minimize pollution and promote cleanliness and sanitation.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

- **Section 1. Title**. This Ordinance shall called an Ordinance on "Pamukaw-Hunahuna-Ang Hinun-anun nahanungod sa Basura sang tagsa ka Panimalay Ordinance".
- **Section 2.** That the subject flyers shall be protected and not to be destroyed, teared, burnt and thrown nor be treated as garbage material;
- **Section 3.** That the flyers herein stated contains pertinent information of actions to be undertaken stipulated in the Municipal Solid Waste Ordinance No. 2010-157 and the ten-year solid waste management plan.
- **Section 4.** That anyone caught showing resistant against and contrary to the flyers herein provided shall be penalized in accordance with Section 68 (25) of Municipal Ordinance No. 2010-157 amending Ordinance No. 96-018 on Comprehensive Solid Waste Management Ordinance.
- **Section 5.** Separability. If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

Section 6. This Ordinance shall take effect upon approval.
