ORDINANCE NO. 2018 - 349

AN ORDINANCE ADOPTING THE REVISED OFFICIAL SEAL OF THE MUNICIPALITY OF MINA

WHEREAS, the official seal of the Municipality of Mina was originally crafted but it needs revision to establish a more clarified interpretation of each quadrant in the seal.

NOW, THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

Section 1. The Revised Official Seal. There shall be adopted a revised Official Seal of the Municipality of Mina illustrated hereunder.



The Revised Official Seal of Mina symbolizes the economic farming activity of the Minanhons being a rice producing Municipality. The quadrants in the seal represent four (4) cycles per season in farming being the major sources of income of the Minanhons.

The concept was originally created in the 70's by the late Oscar D. Pasaporte. It was then a round plate with four (4) quadrants painted which shows the means of livelihood of Minanhons, like farming, labor and fish retailing. In 1993, it was re-designed by then Mayor Lydia E. Grabato.

- 1.) The seal symbolizes the aspiration of Minanhons for the betterment of their lives by making the best uses of its abundant and rich agricultural lands as represented by a predominant green color used;
- 2.) The innermost portion contains four (4) quadrants showing the basic sequence of rice farming in a season, as follows:
 - a. 1st quadrant land and seed bed preparation
 - b. 2nd quadrant planting
 - c. 3rd quadrant harvesting
 - d. 4th quadrant preparing for consumption and/or marketing

- 3.) Colour blue relates the depth and sustainability of the Minanhons and their love for peaceful lives.
- 4.) Colour red signifies bravery and strength of its people.
- 5.) The white colour used in printing words, letters and two strips forming the circles signify purity of hearts and transparency in the local governance;
- 6.) The gears surrounding the seal signifies hope of aiming high to become an agroindustrialized municipality and other aspects of development aside from farming;

The Revised Municipal Official seal is a true picture of the Municipality's identity as it continues to struggle towards the utmost of its dream for development.

Section 2. Use of the Revised Official Seal, presented herein shall is printed, stamped or sewn in all Municipal stationaries, identification card, official documents, banners, signs, porters and other similar materials as authorized by the Municipal Mayor or the Sanggunian Bayan.

Section 3. Prohibition. – Any private person, natural or judicial are prohibited to use, deface or make fun of the revised official Seal (Logo) of the Municipality of Mina.

Section 4. Penalty clause. Any person, natural or judicial, found violating the provision of Section 3 hereof shall be punished with a fine of not less than P500.00 nor more than P1,500.00 or an imprisonment of not less than one (1) month and ten (10) days nor more than four (4) months, or both such fine and imprisonment at the discretion of the court.

Section 5. Repealing Clause. The provision of existing Ordinance inconsistent hereof is hereby deemed modified, amended or repealed accordingly.

Section 6. Effectivity Clause. This ordinance shall take effect upon mandatory publication.
