**ORDINANCE NO. 2018 - 351**

**AN ORDINANCE INCREASING THE SALARY OF JOB-HIRED EMPLOYEES OF THE MUNICIPALITY OF MINA, PROVINCE OF ILOILO, FROM TWO HUNDRED FIFTY PESOS (P250.00) TO THREE HUNDRED PESOS (P300.00) PER DAY AND ANOTHER FIFTY PESOS (P50.00) INCREASE TO BECOME P350.00 EFFECTIVE JANUARY 2019**

WHEREAS, Republic Act No. 6727, otherwise known as the “Wage Rationalization Act” was enacted to establish the minimum wage earners in every region countrywide;

WHEREAS, the Municipality of Mina has Job-Hired workers having a daily wage of Two Hundred Fifty Pesos (P250.00) each which far below the minimum daily wage as above-stated;

WHEREAS, due to the increasing prices of the daily expenses that these workers need to spend for their families, there is a need to raise their daily minimum wage per day from their current rate of P250.00 pesos to P300 per day starting October 1, 2018, and another P50.00 by January 2019 to sustain their necessary expenses.

**NOW, THEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

**Section 1.** This Ordinance shall be known as the “Ordinance increasing the Salary of Job-Hired employee of the Municipality of Mina, Province of Iloilo”.

**Section 2.** The salary of the Job-Hired personnel working in this municipality be increased from Two Hundred Fifty Pesos (P250.00) to Three Hundred Pesos (P300.00) starting first day of October 2018, and another Fifty Pesos (P50.00) increase to become P350.00 effective on January 2019.

**Section 3. Repealing Clause.** – Other related ordinances related inconsistent with this Ordinance are hereby repealed or modified accordingly.

**Section 4. Effectivity.** This Ordinance shall take effect upon approval.
