### ORDINANCE No. 2018 - 353

# AN ORDINANCE LIFTING ORDINANCE NO. 2011-058-A, OTHERWISE KNOWN AS "ORDINANCE REGULATING THE SELLING, DISPOSAL, DRINKING OR CONSUMPTION OF ANY ALCOHOLIC OR INTOXICATING BEVERAGES IN ANY QUANTITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF, AND ORDINANCE NO. 2001-063, "AN ORDINANCE ON CURFEW HOURS FOR MINORS" FROM DECEMBER 14, 2018 TO DECEMBER 23, 2018

WHEREAS, the Municipality of Mina will celebrate its Annual Christmas Presentation, "Paskwa Halad sa Banwa" effective **December 14 - 23, 2018** which includes food fair and Nightly Contest at the Maragtas Recreation Center (MRC) as part of its entertaining activity for the coming-in of guests or visitors;

**WHEREAS,** in order to accommodate this special occasion, there is a need to lift the implementation of aforecited ordinances, and after which the same shall automatically be forceful and effective upon termination of the activity.

### NOW, THEREFORE,

**BE IT ORDAINED** by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

**Section 1.** This ordinance shall be known as "Ordinance Temporarily Lifting the Implementation of Ordinance Nos. 2011-058-A and 2001-063".

**Section 2.** That regulation on the selling, disposal and drinking of any alcoholic or intoxicating as well as curfew hour for minors be temporarily lifted out of the wake of the Paskwa Halad sa Banwa celebration being the municipality's official annual festival from December 14-23, 2018.

**Section 3.** That the condition prescribed in aforestated be resumed and effective upon termination of the said activity.

Section 4. This Ordinance shall take effect on December 14, 2018 up to December 23, 2018.
