RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE REY P. GRABATO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE VI (DSWD-FO6) WITH OFFICE ADDRESS AT M. H. DEL PILAR ST., MOLO, ILOILO CITY REPRESENTED BY DIR. REBECCA P. GEAMALA, REGIONAL DIRECTOR, IN THE MANAGEMENT OF THE RELEASE OF SOCIAL PENSION DUE TO ELIGIBLE SENIOR CITIZENS

WHEREAS, presented for consideration is the letter received from the Office of the Mayor requesting authority from the Sanggunian to sign in the MOA for the management of the release of social pensions due to senior citizens who are eligible and qualified;

WHEREAS, the Social Pension for indigent Senior Citizens is an additional government assistance to augment the daily subsistence and other medical needs of indigent Senior Citizens;

WHEREAS, fund transfer to LGU is identified as one of the modes of payment to fast track the distribution of stipend to the beneficiaries and to strengthen the partnership with LGUs in the effective delivery of programs and services;

WHEREAS, both parties commit to undertake their respective duties and responsibilities as stipulated in the MOA;

WHEREAS, an authority to sign in the MOA by the Municipal Mayor from this Sanggunian is required pursuant Section 444 (b)(i)(vi) of RA 7160.

NOW, THEREFORE:
