**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) WITH ADDRESS AT DILG-NAPOLCOM CENTER, EDSA CORNER QUEZON AVENUE, WEST TRIANGLE, QUEZON CITY, REPRESENTED BY HON. CATALINO S. CUY, OIC-SECRETARY IN THE UTILIZATION OF FINANCIAL ASSISTANCE FROM THE DILG FOR PLEB ENHANCEMENT PROGRAM IMPLEMENTATION**

**WHEREAS**, presented for consideration is the letter received from the office of the Mayor requesting authority from this Sanggunian to sign in the MOA with DILG for People's Law Enforcement Boards (PLEB) Capacity Enhancement Program;

**WHEREAS**, the DILG has administrative and disciplinary, as well as quasi-judicial jurisdiction over the PNP, especially in matters involving the latter's errant and/or wayward members;

**WHEREAS**, the DILG, through the Capacity Enhancement Program for the PLEB, shall provide assistance to LGUs for the implementation thereof, in support of R.A. 6975 or an Act Establishing the Philippine National Police under a Reorganized Department of the Interior and Local Government, and for other purposes;

**WHEREAS**, the creation of and support to offices dedicated to PLEBs, and the provision of life insurance and per diems are essential to the implementation of the PLEB program and in support of R.A. 8551 or the Philippine National Police Reform and Reorganization Act of 1998;

**WHEREAS**, the Local Government of Mina agrees to utilize the subsidy-assistance according to the terms and conditions stipulated in the MOA;

**WHEREAS**, an authority to sign in the MOA by the Municipal Mayor from this Sanggunian is required pursuant Section 444 (b)(i)(vi) of RA 7160.

**NOW, THE REFORE:**
