RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A SPECIFIC IMPLEMENTATION AGREEMENT (SIA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE VI (DSWD-RO6) WITH OFFICE ADDRESS AT M.H. DEL PILAR ST., MOLO ILOILO CITY FOR THE IMPLEMENTATION OF SUPPLEMENTARY FEEDING PROGRAMS, TO WIT: 1) SUPERVISED NEIGHBORHOOD PLAY SUPPLEMENTARY FEEDING – P360,000.00; AND 2) REGULAR SUPPLEMENTARY FEEDING – P901,560.00 FOR CY 2018

WHEREAS, presented for consideration is the letter received from the Office of the Mayor requesting authority to sign in the Specific Implementation Agreement (SIA) with DSWD RO6 for the implementation of supplementary feeding program under the: a.) Supervised Neighborhood Play Supplementary Feeding – P360,000.00; and b.) Regular Supplementary Feeding – P901,560.00;

WHEREAS, both supplementary feedings have separate implementation processes but of the same SIA stipulating therein the duties and responsibilities of both parties to ensure success of their implementation;

WHEREAS, two (2) project proposals to this effect were presented to this Sanggunian as reference of its discussion and deliberation;

WHEREAS, this Sanggunian finds both proposals (1 & 2) beneficial for the needs of our children beneficiaries, thus this authority pursuant to Section 444 (b) (i)(vii) of R.A. 7160.

Now, Therefore:
