WHEREAS, the LGU of Mina is committed to the delivery of Primary Benefit Package Service (PBPS) for health benefit of its constituency renewable every calendar year;

WHEREAS, the rural health unit of Mina is accredited by the National Health Insurance Corporation (PHIC) eligible to implement the National Health Insurance Program (NHIP) as supported by various related documentary papers attesting its capability of delivering the services it applies for;
