WHEREAS, Section 16 of the Local Government Code of 1991 expressly grants the local government unit within their respective territorial jurisdiction to exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, a need for a Memorandum of Agreement specifying the role of the institution represented by its head and the LGU through the Local Chief Executive who is the Chairman of the School Board in which the latter was also tasked to oversee the general welfare of the school and its facilities within this jurisdiction;

WHEREAS, one of the powers of the Local Sangguniang Bayan under Section 447 of the Local Government Code further for the duty of the Sangguniang Bayan pertaining to the use of the land, buildings, and structures within the jurisdiction of the LGU, to inquire and regulate on such use for the general welfare of the Municipality;

WHEREAS, in the process of inquiring on the various activities being held within the territorial jurisdiction of Mina, it is a humble desire of this Resolution to inquire on the status of the post-graduate classes held in many years now at the Mina Central School since the classes require the use of the buildings and facilities of the central school as well as electrical power supply used continuously during classes. Further, the LGU-Mina also seeks to address the safety of the individuals insofar as entering of such other personalities, particularly those taking up master degree, within its jurisdiction is concerned;

WHEREAS, in view of the aforesaid premises, the Sangguniang Bayan of Mina seeks to inquire whether or not the use of the MCS school facilities for the classes above-mentioned, is proper even without proper communication and appropriate coordination with the Local Government, considering the fact that the school is within the jurisdiction of this Municipality.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION OF INQUIRY PERTAINING TO THE USE OF MINA CENTRAL SCHOOL FACILITIES BEING USED FOR THE POST-GRADUATE CLASSES.
