**RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT THROUGH THE PROVINCIAL GOVERNOR, HON. ARTHUR D. DEFENSOR SR., IN THE AMOUNT OF SEVEN HUNDRED FIFTY FIVE THOUSAND TWO HUNDRED EIGHTY PESOS (P755,280.00) FOR THE IMPROVEMENT OF BARANGAY ROADS IN THE MUNICIPALITY OF MINA**

**WHEREAS**, the Municipality of Mina is a struggling 5<sup>th</sup> class municipality but now becoming a fast developing town, maximizing its entire resources to the fullest to cope with realities and visions of local autonomy;
