TO ENTER AND SIGN INTO A ONE (1) JOB CONTRACT, RE: FURNISHING OF LABOR AND MATERIALS, WITH NOE'S BUILDERS, REPRESENTED BY NOEMI GEVERO, OWNER/PROPRIETOR, WITH BUSINESS ADDRESS AT BANTUD ST., INGORE, LAPAZ, ILOILO CITY FOR THE CONSTRUCTION OF PARKING AREA AND DECORATIVE TILES AND BRICKS INSTALLATION**

**WHEREAS**, presented for consideration is the letter received from the Office of the Mayor, requesting authority from this Sanggunian to sign in the One (1) Job Contract for the Construction of Parking Area and Decorative Tiles and Bricks Installation;

**WHEREAS**, the LGU of Mina has appropriated certain amount of Six Hundred Thousand Pesos (P600,000.00) for the above-stated project to conveniently serve clients having official transactions within the Municipal building, effective and efficient public service and for other purposes for the welfare of its people pursuant to Section 16 of RA 7160;

**WHEREAS**, the said amount was submitted to a public bidding for One (1) Job contract, and the lowest calculated responsive bid was awarded to Noe's Builders in the amount of Five Hundred Ninety Eight Thousand One Hundred Four Pesos and 60/100 (P598,104.60);

**WHEREAS**, to sign in the Contract by the Municipal Mayor needs authority from this Sanggunian, pursuant to Section 444 (b)(vi) of RA 7160, hence this resolution.
