TO ENTER AND SIGN INTO A ONE (1) JOB CONTRACT, RE: FURNISHING OF LABOR AND MATERIALS, WITH NOE'S BUILDERS, REPRESENTED BY NOEMI GEVERO, OWNER/PROPRIETOR, WITH BUSINESS ADDRESS AT BANTUD ST., INGORE, LAPAZ, ILOILO CITY FOR THE IMPROVEMENT OF EVACUATION/RECREATION CENTER AT BARANGAY MINA WEST, MINA, ILOILO**

**WHEREAS**, the newly constructed evacuation center can be utilized into dual purposes – as evacuation center during calamities or disaster and as sports facility when there is sports development program to be held in this Municipality;

**WHEREAS**, as evacuation center and sports facility, the building needs more improvement by providing concrete bleachers within, as well as other needs to suit with its purpose/s;

**WHEREAS**, the amount of Two Million Pesos (P2,000,000.00) was made available from the Municipality's 20% development fund to finance the said project; and the same was submitted to a public bidding in which the Noe's Builders got the lowest responsive calculated bid to whom the contract was awarded to;

**WHEREAS**, an authority to sign in the one (1) Job Contract by the Municipal Mayor from this Sanggunian is required pursuant to Section 444 (b)(vi) of RA 7160.
