RESOLUTION REQUIRING THE EXSISTING AGRO-INDUSTRIAL AND INDUSTRIAL OWNERS AND OTHER RELATED ESTABLISHMENTS TO SUBMIT UPDATED ECC AND ENVIRONMENTAL MONITORING REPORT TO THE ENVIRONMENTAL MANAGEMENT BUREAU, COPY FURNISHED THIS MUNICIPALITY THROUGH THE MUNICIPAL LICENSING OFFICE AND THE SANGGUNIANG BAYAN, ALL OF MINA; AND FURTHER TO SUSPEND NEW APPLICATIONS FOR THE ESTABLISHMENTS OF NEW OR EXPANSION OF POULTRY AND HOG RAISING FOR THE PERIOD OF THREE (3) YEARS

WHEREAS, all agro-industrial and industrial owners, whether poultry, hogs, factories and the likes, are required to secure an Environmental Compliance Certificate (ECC) from the DENR, through the Environmental Management Bureau (EMB) prior to their operation to ensure safe and healthy environmental condition of its surroundings that will not affect the health of the people;

WHEREAS, most of the establishment owners did not comply some of the conditions stipulated in the ECC particularly the environmental monitoring report using the self-monitoring report EMB-EIA MForm No. 03 provided for such purpose;

WHEREAS, due to numerous existing in this municipality, rapid multiplication of flies are now out of control that prompted those who are affected to raise their complaints, thus suspension of new applications as above-stated is necessary unless otherwise effective mitigation to control the voluminous spread of flies had been introduced;

WHEREAS, likewise, there is a need for the existing establishment owners to update their ECC and submit the same to the LGU for proper monitoring and evaluation.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **ESOLUTION REQUIRING THE EXSISTING AGRO-INDUSTRIAL AND INDUSTRIAL OWNERS AND OTHER RELATED ESTABLISHMENTS TO SUBMIT UPDATED ECC AND ENVIRONMENTAL MONITORING REPORT TO THE ENVIRONMENTAL MANAGEMENT BUREAU, COPY FURNISHED THIS MUNICIPALITY THROUGH THE MUNICIPAL LICENSING OFFICE AND THE SANGGUNIANG BAYAN, ALL OF MINA; AND FURTHER TO SUSPEND NEW APPLICATIONS FOR THE ESTABLISHMENTS OF NEW OR EXPANSION OF POULTRY AND HOG RAISING FOR THE PERIOD OF THREE (3) YEARS.**
