**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE VI (DSWD-RO6) REPRESENTED BY DIR. REBECCA P. GEAMALA, M.H, DEL PILAR ST., MOLO, ILOILO CITY FOR THE IMPLEMENTATION OF CASH FOR WORK PROGRAM IN THE MUNICIPALITY OF MINA**

**WHEREAS**, thousands of victims of climate change were affected by drought, heavy flooding, rising of sea level, low production and other ecological, social and economic impacts;

**WHEREAS**, due to the reported impacts of climate change and its adverse effect, it resulted to widespread hunger, displacement and even death;

**WHEREAS**, the DSWD is mandated to provide augmentation support to LGU and other entities in adaptation and mitigating impacts of climate change, uplifting the lives of the disadvantage population, i.e. Pantawid Pamilyang Pilipino Program (4Ps) beneficiaries, Listahan-Poor, Indigenous People, members of the vulnerable section like the youth, women, persons with disability, and other individuals/families in crisis situation, (victims of man-made and natural disaster);

**WHEREAS**, the DSWD, in attaining its mandate is willing to provide technical and financial assistance to LGUs to be conduit in the provision of basic services and implementation of its program;

**WHEREAS**, the amount of Two Million Five Hundred Twelve Thousand Six Hundred Twenty Pesos (P2,512,620.00) was approved the Cash for Work under the climate Change Adaptation Mitigation;

**WHEREAS**, the above-stated approved amount was for labor fee or cash allowance for road clearing, communal garden, drainage, waterways clearing, repair and maintenance of Barangay roads, and slope protection in the Municipality of Mina;

**WHEREAS**, in order to effect successful implementation of the program, there shall be a need to execute a MOA between the DSWD and its conduit LGU;

**WHEREAS**, an Authority to sign by the Municipal Mayor in the MOA from this Sanggunian is necessary pursuant to Section 444 (b) (1) (vi) of RA 7160

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P.
