YUGOT BULIG SA KABUHI PEOPLE'S ORGANIZATION REPRESENTED BY ITS PRESIDENT AZELA CAMBALO, AND OTHER STAKEHOLDERS REPRESENTED BY JOSE P. CASQUEJO, YUGOT, MINA, ILOILO FOR THE IMPLEMENTATION OF KALAHYAN CIDSS-NCDDP SUBPROJECT GRANT TIER-2, RE: CONSTRUCTION OF ONE (1) TWO (2) CLASSROOM ELEMENTARY SCHOOL BUILDING WITH AMENITIES**

**WHEREAS**, the DSWD, through the KALAHYAN CIDSS-NCDDP funded the priority subprojects of communities during the Municipal Inter-Barangay Forum;

**WHEREAS**, the community, with the leadership of Barangay Subproject Management Committee (BSPMC) and the assistance provided by the Barangay and Municipal Local Government Units and other stakeholders satisfactorily identified their subproject entitled maintenance Improving Access to Quality Basic Education through Community Managed Construction of one (1) unit two (2) classroom Elementary School Building with Amenities;

**WHEREAS**, the community, municipal and Barangay LGUs and other stakeholders (if applicable) shall share the operation and maintenance responsibilities to sustain the delivery of services provided by the completed subproject through proper and timely, operation and maintenance (O & M) activities;

**WHEREAS**, the Barangay LGU (BLGU) shall primarily be responsible and accountable in ensuring that O & M activities are implemented as planned;
