**RESOLUTION REQUESTING FINANCIAL SUPPORT FROM THE DEPARTMENT OF AGRICULTURE, THROUGH THE REGIONAL DIRECTOR REMELYN R. RECOTER, DA-RFO VI, ILOILO CITY, IN THE TOTAL AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) FOR THE CONCRETING OF FARM-TO-MARKET ROADS (FMR) IN FIVE DIFFERENT BARANGAYS OF THE MUNICIPALITY OF MINA, TO WIT: (A) TOLARUCAN- P10,000,000.00; (B) TIPOLO- P10,000,000.00; (C) TALIBONG PEQUEÑO- P 10,000,000.00; (D) NASIRUM- P10,000,000.00; AND (E)GUIBUANGAN – P10,000,000.00**

**WHEREAS**, Section 16 (b)(2)(vii) shall provide infrastructure facilities intended primarily to service the needs of the residents, including but not limited to, municipal roads and bridges, etc;

**WHEREAS**, the barangays above-mentioned are all prime agricultural Barangays serviced by the existing rough roads (FMR) to conveniently transport farm inputs and production of the farmers, as well as, commuters from and to the market place or town proper;

**WHEREAS**, such FMR always incur damages every rainfall comes despite regular maintenance and repair being made thereto every summer season, thus creating inconvenience to the general public and making it inefficient in terms of basic service delivery;

**WHEREAS**, in view of this, and in order to effect efficient service to the people in terms of transportation accessibility, it is deemed very necessary to concretize the FMR above-mentioned;

**WHEREAS**, the municipality has no available funds to finance the implementation of these very indispensable concreting, hence this request.
