RESOLUTION No. 2018 - 073

RESOLUTION APPROVING MDC RESOLUTION NO. 2018-05, RE: REQUEST FOR THE REALIGNMENT OF FOUR MILLION ONE HUNDRED FIFTY THREE THOUSAND NINE HUNDRED FORTY PESOS AND 39/100 (P4,153,940.39) OF THE 20% DF CONTINUING APPROPRIATION FROM THEIR RESPECTIVE ORIGINAL PROGRAM TO OTHER URGENT PURPOSES IDENTIFIED BY THE MDC

WHEREAS, the MDC proposes to realign the lump sum amount of P4, 153,940.39 from the 20% continuing appropriation from: a) Repayment of Loan Amortization – P1,593,940.39; b) Regravelling and improvement of FMR – P 1,100,000.00; c)Acquisition of Land for Socialized Housing – P 1,460,000.00 to the following urgent needs: a) Installation of Streetlights – P 250,000.00; b) Aid to 22 barangays for the Construction and/or Improvement of their respective Multipurpose Building – P2, 200,000.00; c) construction of Additional Room for Persons who used drugs (PWUDS) and MADAC office that will serve as the venue for drug related Educational symposiums and conferences – P700,000.00; d) Improvement of Multipurpose Building (P500,000.00); e) Completion of Public C.R. at Mina West – P300,000.00; and f) Other Development Projects – P 203,940.39;

WHEREAS, the total amount of P4,153,940.39 above-stated from the previous year's continuing appropriations were not spent for their specific program as identified due to the following reasons:

- a) **The fund appropriated for the repayment of loan amortization has an accumulated savings which made it available for other priorities;**
- b) **The fund appropriated for the regravelling and improvement of farm-to-market roads (FMR) were not spent as some of the FMR were improved and regavelled using funds of the barangays concerned and the province through its truck team used to augment the municipality/Barangay in the repair and maintenance of the same;**
- c) **The amount appropriated for the acquisition of land for socialized housing is still available to date as the LGU could not find available lot for sale for this purpose;**

WHEREAS, in view of the above, the MDC decided to realign the above-stated balances from the continuing fund to a more urgent but beneficial to every Minanhons;

WHEREAS, looking at the benefits that the Minanhons can avail from out of this realignment, this Sanggunian favorably considered MDC Resolution No. 2018-05, hence this approval.

NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mina, Province of Iloilo to pass a **RESOLUTION APPROVING MDC RESOLUTION NO. 2018-05, RE: REQUEST FOR THE REALIGNMENT OF FOUR MILLION ONE HUNDRED FIFTY THREE THOUSAND NINE HUNDRED FORTY PESOS AND 39/100 (P4,153,940.39) OF THE 20% DF CONTINUING APPROPRIATION FROM THEIR RESPECTIVE ORIGINAL PROGRAM TO OTHER URGENT PURPOSES IDENTIFIED BY THE MDC.**
