**RESOLUTION NO. 2018 - 083**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL POLICE COMMISSION, REPRESENTED BY ATTY. JOSEPH S. CELIS, REGIONAL DIRECTOR, FUENTES-LEDESMA ST., ILOILO CITY AND THE MINA MUNICIPAL POLICE STATION REPRESENTED BY PSI MA. THERESA GABINETE LERO, MINA, ILOILO FOR THE IMPROVED PEACE AND ORDER AND PUBLIC SAFETY PROGRAM**

**WHEREAS**, presented for consideration is the letter coming from the office of the mayor, requesting authority to sign in the MOA with the NAPOLCOM and the Mina PNP pursuant to Section 444 (b) (1) (vi) of RA 7160;

**WHEREAS**, the Municipality of Mina has been focused on the systems improvement through different programmes such as: Minanhons Ayaw sa Druga (MAD), I Heart You Project, Hinun-anon sa Pamatan-on, and Traffic Summit.

**WHEREAS**, the NAPOLCOM, in line with Section 2 of RA 8551, otherwise known as “The PNP Reform and Reorganization Act of 1998”, is instituting Community and Service Oriented Policing as the foundation and backbone of community-service oriented policing and crime prevention in the country;

**WHEREAS**, the DILG is pushing for the strengthening of the Peace and Order Councils (POCS) of LGUs (in Memorandum Circular) through the adoption of Peace and Order and Public Safety (POPS) Planning, a methodical process that will develop a plan responsive to the local criminality and other security and public safety issues and supportive of the LGUs Comprehensive Development Plan;

**WHEREAS**, Section 64 of RA 8551 also provides that the Governors and Mayors, upon having been elected and having qualified as such, are automatically “deputized as representatives of the NAPOLCOM in their respective jurisdiction”;

**WHEREAS**, a MOA to this effect was crafted to faithfully implement and comply with all the terms and conditions stipulated in the contract.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL POLICE COMMISSION, REPRESENTED BY ATTY. JOSEPH S. CELIS, REGIONAL DIRECTOR, FUENTES-LEDESMA ST., ILOILO CITY AND THE MINA MUNICIPAL POLICE STATION REPRESENTED BY PSI MA.
