**RESOLUTION GRANTING CASH REWARD TO THE MEMBERS OF THE MINA PNP LED BY PSI MA. THERESA G. LERO FOR THE ARREST OF MELARD PASAPORTE Y LEDESMA OF BRGY. MINA WEST, MINA, ILOILO FOR VIOLATING R.A. 9165 OTHERWISE KNOWN AS "ANTI-DRUGS REGULATION ACT"**

WHEREAS, at about 10:00 o'clock in the morning of July 13, 2018, operatives of the Mina Police Station composed of PO2 Franklin Luzarita, PO2 Andy Datiles, PO2 Titius Ortiga and PO2 Rodolfo Barranco, Jr., designated as direct back-up and SPO1 Deo Adorable, member of PDEU Team 2, IPPO, designated poseur buyer under the supervision of PINSP Ma. Theresa G. Lero, Mina Chief of Police and IPPO PDEU Team 1 led by PSINSP Francis Fortunado with members, PO3 John Samania, PO3 Joseph Siter, PO2 Jovy Baconaje, PO1 Alkaid John Halanes and PO1 Niel Romee Cabanting and IPPO PDEU Team 2 lead by PSINSP Fernando Ponsalan, Jr. with members Franklin John Luzarita and PO2 Alejo Dillo were dispatched to conduct buy bust operation against Brgy. Lgd. Melard Pasaporte y Ledesma, 40 years old, married and a resident of Brgy. Mina West, Mina, Iloilo;

WHEREAS, at about 10:35 o'clock in the morning of July 13, 2018 the said teams conducted buy bust operation at Del Pilar St., Brgy. Mina West, Mina, Iloilo which resulted to the arrest Melard Pasaporte y Ledesma alias "Bitoy". Among the items recovered from the suspect were five (5) pcs. One hundred peso bills marked money bearing serial numbers AS791647, CP25109, EB024864, HS53427, and one (1) 500 peso bill with SN DY0477 or with a total of One Thousand Pesos (P1,000.00) Philippine Currency and one (1) piece heat sealed transport plastic sachet containing crystalline substance of suspected shabu;

WHEREAS, Melard Pasaporte y Ledesma, alyas Bitoy is detained in the Mina PNP of the crime committed and for proper charges in court;

WHEREAS, in view of the aforementioned, the Mina PNP led by PSINSP Ma. Theresa G. Lero deserves an award under the policy program of the present administration for the job well done, hence this resolution.
