#### **RESOLUTION NO. 2018 - 104**

RESOLUTION APPROVING THE RECOMMENDATION OF THE DSWD REGIONAL OFFICE VI, ILOILO CITY TO WAVE THE PROJECT OF BARANGAY SINGAY, MINA, ILOILO, AND FURTHER AUTHORIZING THE MUNICIPAL TO SIGN IN THE WAIVER

WHEREAS, Barangay Singay is one among the seven (7) barangays who availed of the KALAHI CIDSS-NCDDP Tier-2 subproject grants for Improving Basic Access Infrastructure through Community Managed Concreting of Barangay Road at Purok 1 and 3, but due to some technical problems incurred, its implementation was delayed which did not hit the timeline requirements;

WHEREAS, in view of this, the DSWD Regional Office VI, upon the lapse of the required timeline, recommended for the return of the budget back to the DSWD National Office and recommended further to waive the said budget to the concerned agency;

WHEREAS, the barangay has no other option but to confirm with the recommendation of DSWD RO VI despite its request for a reconsideration;

WHEREAS, a waiver to this effect shall be executed by the party/ies concerned wherein one (1) of the signatories is the Municipal Mayor who has the jurisdiction over the barangay;

WHEREAS, an authority to sign in the Waiver by the Municipal Mayor, from this Sanggunian is required pursuant to Section 444 (b) (1) (vi) of RA 7160.
