RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE HONORABLE SENATOR SONNY ANGARA, HOUSE OF THE SENATE, MANILA FOR THE CONCRETING OF SIX (6) KILOMETERS FARM-TO-MARKET ROAD FROM BRGY. MINA EAST, SINGAY, AND AGMANAPHAO, MINA, ILOILO

**WHEREAS,** the Municipality of Mina, a 5<sup>th</sup> class, is a prime agricultural land with rice as its major crop;

WHEREAS, the vast irrigated rice land of the Municipality covering the our (4) barangays, namely: Mina East, Singay, Agmanaphao and Badiangan is serviced by a farm-to-market road (FMR) about six (6) kilometers more or less, which used to cater commuters and transportation of goods from and to the market place;

WHEREAS, the subject road was initially concreted with funds from the LGSF-ADM about one (1) kilometer more or less, but the remaining portion about six (6) km., more or less oftenly incur damages every rainfalls by creating big spot holes until it becomes unpassable. This finds difficult for everyone to travel through, and to transport goods especially farm inputs and productions;

WHEREAS, this particulars road connects these four (4) barangays above-mentioned to the national highway in which is a short cut way from the Mina town proper to the city of Iloilo;

WHEREAS, concreting of the said road section is very essential for the convenience of the Minanhons especially farmers as it will greatly improve the economic and social conditions of the populace, and will reduce maintenance costs as well.
