RESOLUTION APPROVING LPRAT RESOLUTION NO. 001, SERIES OF 2018 REQUESTING THE THIRTEEN (13) BARANGAYS, NAMELY: AGMANAPHAO, BADIANGAN, CABALABAGUAN, CAPUL-AN, GUIBUANGAN, MINA EAST, NASIRUM, NAUMUAN, SINGAY, TELIBONG GRANDE, TALIBONG PEQUEÑO, TUMAY AND YUGOT TO ALLOCATE COUNTERPART FUND FOR THE IMPLEMENTATION AND COMPLETION OF THIRTEEN (13) DAY CARE CENTERS UPGRADING AND REHABILITATION

WHEREAS, the Municipality of Mina is a recipient of the DSWD flagship program from the BUB 2016 amounting to Three Million Pesos (P3,000,000.00) for the upgrading and rehabilitation of day care center buildings in 13 barangays above-mentioned as prioritized by the LPRAT;

WHEREAS, program of works and technical plans had been initially prepared in accordance with the budget released, but upon publication with the PhilGEPS, no supplies was able to submit bid proposal due to high cost of materials and other related works which were not considered in the preparation of program of works and technical plans;

WHEREAS, it was previously decided that the projects shall be done by way of administration, but due to lack of manpower, it was decided again to revised the program of works, and be implemented by way of contract;

WHEREAS, in view of this, there had been insufficiency of funds incurred, thus counterpart fund from the barangays concerned shall be needed.

NOW, THEREFORE:
