RESOLUTION AUTHORIZING THE INSTITUTION OF CIVIL ACTIONS FOR COLLECTION OF MARKET RENTALS, FEES AND CHARGES AGAINST DELINQUENT LESSEES AND VENDORS OF MINA PUBLIC MARKET, INCLUDING THE FILING OF APPROPRIATE CASE/S AGAINST FORMER STALL OWNERS/LESSEES AND FOR THAT PURPOSE THE LOCAL CHIEF EXECUTIVE AND/OR THE MARKET SUPERVISOR IS HEREBY AUTHORIZED TO REPRESENT THE MUNICIPALITY IN THE PROCEEDINGS

WHEREAS, presented for consideration of this August Body is the authorization of the Municipality to institute necessary civil actions for the collection of market rentals, fees and charges against delinquent market lessees and vendors, including former stall owners/lessees;

WHEREAS, the initiation of such proceedings requires the approval of the Sangguniang Bayan and its grant of authority to the Local Chief Executive to initiate the civil action and to represent the Municipality in the proceedings;

WHEREAS, upon deliberation, this Honorable Body deemed it wisely to approve the herein resolution.

NOW, THEREFORE:
