It is now considered as one of the new tigers among ASEAN nations amid strong economic growth. Opportunities abound for investors targeting the sectors of business process outsourcing, electronics, agriculture, renewable energy, and infrastructure. The programs and activities of the Senior Citizens in Mina had met all the criterion set for the contest, thus defeating other opponents in the Province of Iloilo.



As a result the Municipality of Mina was able to revise its Comprehensive Land Use Plan (CLUP) streamlining Disaster Risk Reduction and Climate Change Adaptation effective Year 2016-2025, it was already adopted and approved by the Sangguniang Panlalawigan of Iloilo on December 13, 2016. The success of the completed project in the Municipality of Mina is now one of the models of other ASEAN municipalities in the formulation of their own CLUP, Being a 5th class income municipality in the Province of Iloilo did not hinder us to be known in other ASEAN Countries. During the first stakeholders' meeting and inception workshop of the ASEAN Adopt a Municipality for Resilient and Recovery Project, on February 17, 2015 in Iloilo City, Philippines the statement of the ASEAN Deputy Secretary-General Alicia Bala, ... "this project will enable the four pilot areas where Mina is one of them to "bounce forward" instead of "bounce back" and help operationalize the principle of "building-back-better-faster-and-safer" towards reducing vulnerability and increasing resilience to disasters. This project is also a continuing manifestation of ASEAN solidarity towards building a "caring and sharing ASEAN Community".



CLIMATE SMART FARM BUSINESS SCHOOL. The Municipal Agriculture Office conducts a Rice-based Season-long training that can help develop and improve entrepreneurial skills and weather and climate-based decision making skills that can help improve the production of farmers in Barangay Janipa-an West and Naumuan which are highly vulnerable to climate related risk like drought caused by rainfed condition and flooding caused by overflowing of natural rivers during heavy rains. Weekly activities are conducted for a period of 20 weeks.



RELEASING OF CERTIFIED RICE SEEDS TO FARMERS UNDER THE RICE SEED SUBSIDY PROGRAM OF THE DEPARTMENT OF AGRICULTURE AND CROP INSURANCE REGISTRATION. 670 Bags of certified seeds are given to rice farmers in Irrigated and Rainfed ecosystem of the Municipality. This records the most number of certified seeds released in One cropping season only under the leadership of Department of Agriculture Secretary Manual Piñol. The crops of the recipients are then enrolled in the insurance Program of the Philippine Crop Insurance Corporation to ensure that farmers will get compensatory claims in the event of loss or damage in crop production. This program minimizes the losses of farmers caused by a natural calamity pest infestations and diseases.

respective account. It provides accurate status of the budget particularly the balances and the proper posting into budget allocations, thereby ensuring that there will be no overcharging for each item and it also provides the decisionmakers precise and accurate reports of the status of the balances of each item in the budget.

It streamlines the process of the Offices of Budget, Accounting, Treasury and linked with the Office of the Mayor. The system was specially enhanced to improve the quality of government service given to its clients. It speeds up transactions, increases data accuracy and it ensures that expenditures are aligned to budget allocations for the current year. Its timely recording and more accurate computation of disbursements makes it a watch dog for finances, ensuring a more transparent financial operation of government funds. At the same time, it avoids the manipulation and tampering of records and disbursement and it lessens manpower and the work load of employees.

While it promotes transparency in financial transactions and free flow of information between offices, sensitive personal information remains secured. Log-in systems are utilized and only authorized users are given access codes. It is clear as to who are the ones liable and responsible for every transactions encoded in the system.

ENROLLMENT

This interactive, network-oriented computer program is probably the first of its kind in the whole country and can easily be replicated by other LGUs using the software developed by the Mina-LGU. It is a stand-alone server-based system, user-friendly and workable with My SQL-database. It is a client server application that smoothly runs on network environment with any Microsoft Windows Operating System. It is easy to operate and maintain and does not require highly technical IT personnel.

It is an effective and efficient computer-based system that modifies the traditional mode of record management in Budget, Accounting and Treasury Office. Since it can be connected to Mayor's Office as well, it provides an easier access to monitoring and tracing of financial transactions.

It has Search Features and Filtration for Budget, Accounting and Treasurer's Office. It generates major reports and makes it readily available. It improves organizational effectivity and efficiency as it simplifies internal procedures, empowers front liner personnel, improves information flow and enables management to come up with more informed and rational decisions. It minimizes paper-based documentation and easily reconciles records among different Offices.

Municipal Health The Office (MHO) personnel attended the Responsible Parenthood and Reproductive Health (RPRH) coaching and mentoring in Mina Iloilo on November 21, 2017.

RA 10354 known as "Responsible Parenthood and national and local government Reproductive Health Act of 2012", an act providing for a national policy on responsible parenthood and reproductive law, health. The which stemmed from the strong advocacv of stakeholders and the commitment of the Government, is a point for convergence of multi-sectoral Resource for Health (HRH) efforts toward the improvement of health outcomes of the country. It mandates the government to adequate address the needs of Filipinos on responsible parenthood and reproductive health. The law aims to empower the Filipino people, especially women and youth, through informed choice and age- and development-

appropriate education. Further, the law guarantees access to information, facilities and services most especially for the poor by ensuring stable and sustainable reproductive health programs are in placed through partnerships between in collaboration with CSO, basic sectors, academe and private sector. The Provincial Health Office with Elizabeth Bañez, Nurse in-charged of RPRH conducted coaching and mentoring to the Rural Health Midwives, Public Health Nurses and Human personnel. The topics were, Orientation of RA 10354, Forms to be used and activities for the implementation of the program, clarification of the criteria to be used for identifying Women with Unmet needs and provision of FP services in their catchment areas for the last quarter of the year.

They are of long duration and generally slow progression. The four main types of noncommunicable diseases are cardiovascular diseases (like heart attacks and stroke), cancers, chronic respiratory diseases (such as chronic obstructed pulmonary disease and asthma) and diabetes. NCDs already disproportionately affect low- and middle-income countries where nearly 80% of NCD deaths -29 million - occur. They are the leading causes of death in all regions except Africa, but current projections indicate that by 2020 the largest increases in NCD deaths will occur in Africa. In African nation's deaths from, NCDs are project to exceed the combined deaths of communicable and nutritional diseases and maternal and perinatal deaths as the most common causes of death by 2030. All age groups and all regions are affected by NCDs. NCDs are often associated with older age groups,



overweight and obesity. This are called 'intermediate risk factors', which can lead to cardiovascular disease, NCD. With these facts given by the Department of Health, the Provincial Health Office, with Catalina Pugal, PHO-Nurse NCD advocate and

Of these "premature" deaths, 90% occurred in low- and middle-income countries. Children, adults and the elderly are all vulnerable to the risk factors that contribute to non-communicable diseases, whether from unhealthy diets, physical inactivity, exposure to tobacco smoke or the effects of the harmful use of alcohol. Diseases are drive by factors that include ageing, unplanned urbanization, rapid and the globalization of unhealthy lifestyles. For example, globalization of unhealthy lifestyles like unhealthy diets may show up in individuals as raised blood pressure, increased blood glucose, elevated blood lipids,




F. CARPENTRY, MASONRY AND EIM (Electrical Installation Maintenance)

From July to November, 2017, three Hundred Thirty Six (336) beneficiaries were identified as recipients for the Hog Raising and Four (4) for Goat Raising respectively. A total of 400 individuals which are a combination of 4Ps, victims of Typhoon Yolanda and Bulig sa Kabuhi members are beneficiaries. Individually for hog raising two head of piglets were distributed while 3 goats are given individually. Mina MPS Launches "Hinun-anon sa Pamatan-on"





The project is intended to address issues and concerns of young people and to draw their awareness about laws on children, illegal drugs, risky behaviors, gang wars and teen age pregnancy. The project is further supplemented by an Executive Order No. 30 issued by Hon. Rey P. Grabato, Municipal Mayor, an order to conduct "Hinun-anon sa Pamatan-on" in the Municipality of Mina. The launching of the project was held at Mina National High School Covered Gvm on July 25. 2017 at 1:00 o'clock in the afternoon. It was participated by Grades 9-12

students. The activity's setting is like a television show where invited resource persons from RHU, MSWDO/Balay Pagla-um, Provincial Population Office, church and PNP are interviewed by talk show host about risky behaviors that a number of young people seem to be practicing without realizing possible consequences of their actions. The hosts have the outline of the whole discussion and gave the lead on how the discussion will proceed. Each of the resource persons is given time to give their opening statements one after the other. After which, the audience was invited to ask their questions or simply share their thoughts or feelings to whoever they wish to direct their questions. The show tackled issues on vices (alcohol, drugs, smoking, gambling), hygiene, school problems, domestic problems, premarital sex. love and relationship etc. A "Hugot Board" was also made available for the students to post their hugots in the board and after which it was being process and some of it was answered by the speakers. Those students who are brave enough to ask questions personally and those who have their hugot lines open up are given personalized key chains and highlighters as reward. The activity was very interactive and fun. It was attended by two hundred twenty six (226) students and twenty (20) teachers.
