RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH BCPC MEMBER (KAGAWAD ASSIGNED) AND VAWC DESK OFFICER AS THE NETWORK OF VOLUNTEER REPRESENTED BY IT'S LIGA PRESIDENT, HON. FELIPE ALLAGA, LIGA HALL, MINA, ILOILO IN THE FULL IMPLEMENTATION OF PROTECTIVE SERVICE AT THE BALAY PAGLAUM

WHEREAS, the Balay Paglaum was established to resolve cases on children in conflict with the Law (CICL) and other behavioral patterns problems to rescue, assist and protection individuals and families, women and children in crisis situation;

WHEREAS, the same also serves as temporary shelter and restorative services to children and women, and CICL for placement setting and for other rehabilitative related services;

WHEREAS, the baranggay are considered as stakeholders in the full implementation of the protective service to safeguard the future Minanhons which is the prime resource for continued development;

WHEREAS, a network of on call volunteers, specifically volunteer houseparent shall render service in the Balay Paglaum in accordance with the terms and conditions stipulated in the MOA;

WHEREAS, an authority to sign by the Municipal Mayor from this Sanggunian is required pursuant to Section 444 (2) (i)(vi) of RA 7160.
