WHEREAS, pursuant to the two (2)-year Midwifery Scholarship Program of the Philippines (MSPP) in consideration of the scholarship awarded to Lynneth C. Gumban, hereby agrees to serve the Municipality of Mina, Province of Iloilo, as identified priority area of the DOH as a Rural Health Midwife (RHM) under the Rural health Midwives Placement Program (RHMPP) of a period of four (4) years upon completion of the scholarship grants as per Memorandum Order No. 2009-0302 dated November 25, 2009;

WHEREAS, Lynneth C. Gumban has been in this municipality as Rural Health Midwife, under the MSPP of the DOH but her Contract of Services already expired hence renewal of the same is necessary.
